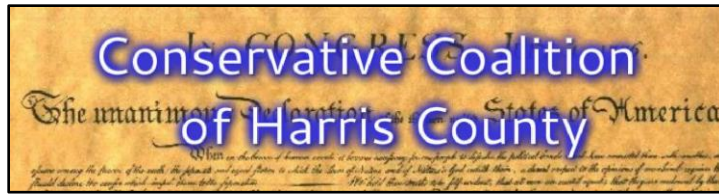

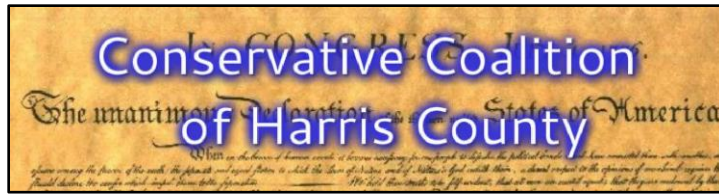


Contested State Races:

We interview the candidates and then our panel members vote by secret ballot on who is the best candidate for each race. Our results should be similar to how conservative voters will vote in each election. Our voting results allows each conservative voter to quickly narrow down the best conservative candidates in each race. The voter can then visit our website to review the candidates' CCHC questionnaire answers so they can make a final decision on their choice in each race.

CCHC PAC is basically self-funded and raises money from our panel members during election cycles. We are a group of unpaid volunteers, and no funds of any type were solicited, accepted or used from any active political candidates, their families, their co-workers, their staff or their campaigns (*unlike other groups in Harris county that have the reputation of accepting fees and donations from candidates*).
