1. Why are you running for City Controller? If elected, what will be your priorities?

Answer: I AM A PUBLIC SERVANT AT HEART AND KNOW MY EXPERTISE CAN HELP TO SECURE THE CITY OF HOUSTON'S FINANCIAL SECURITY NOW AND IN THE FUTURE. MY INTIMATE KNOWLEDGE OF THE CITY OF HOUSTON'S BUDGET, INNER WORKINGS OF CITY PROCESSES, FINANCIAL IMPACTS OF LEGISLATION, AS WELL AS FINANCIAL PROWESS TO KNOW HOW TO TAKE THE CITY OF HOUSTON'S FINANCIAL HEALTH TO THE NEXT LEVEL SET ME APART.
