3. What will be your top 2 or 3 priorities during this upcoming term?

Answer:

1. Uphold the Rule of Law

- **Border Security: Implementing strict border control measures to uphold national security and the integrity of immigration laws.**
- **Gun Rights: Defending the Second Amendment and opposing any legislation that infringes on the right to bear arms.**

2. Limit the Government

- **Economic Prosperity: Promoting free-market principles, tax reforms like the FairTax, and reducing governmental interference in the economy.**
- **Healthcare and Medical Liberty: Advocating for free-market healthcare solutions and opposing government-run healthcare; ensuring medical freedom, including opposition to forced vaccinations.**

3. Accountability in Congress

- **Legislative Transparency: Ensuring all legislation is clear, focusing on single-subject bills to enhance understanding and prevent hidden legislative agendas.**
- **Term Limits and Ethical Governance: Championing term limits to prevent long-term entrenchment in Congress and proposing measures to avoid conflicts of interest, such as banning stock trading by Congress members.**

4. What is your position about massive immigration over our southern border? Should the federal government renew financing and building the border wall with Mexico?

Answer: With over 8 million illegal entries since President Biden took office, the massive immigration crisis at our southern border is an apparent failure of the federal government to perform its constitutional duty as outlined in Article IV Section 4.

This influx directly threatens the safety and well-being of communities across Texas, particularly in East Montgomery County and NE Harris County, including New Caney, Kingwood, and Huffman.

To address this crisis effectively, I propose a comprehensive plan that includes a moratorium on immigration to reassess and strengthen our border policies, a lockdown of ports of entry to prevent illegal crossings, and an end to incentives such as welfare, healthcare, and benefits for illegal aliens.

Furthermore, it's essential to terminate the 'catch and release' policy and deploy additional forces to actively repel and prevent illegal border crossings.

These measures are vital for restoring order and ensuring the safety of our constituents in TX-2.

As for renewing financing and building the border wall, it should be part of a broader, multifaceted strategy for border security. A physical barrier is a significant deterrent and helps manage legal entries more effectively.

However, it must be supplemented with other measures as part of my comprehensive plan to secure our borders and uphold the integrity of our nation.

5. Should the US Congress legislate that November elections are under Federal control rather than the states regulating their own elections? What is the Federal government's role in setting voting rules and procedures for these elections, if any?

Answer: As a staunch supporter of states' rights and the Constitution, I do not believe that the U.S. Congress should legislate to take control of November elections from the states. The Constitution delineates the powers between the federal and state governments, with the Tenth Amendment reserving powers not granted to the federal government for the states and the people.

The founding principle of our Republic is that states should have the primary role in regulating their own elections. This decentralized approach ensures that election laws and procedures are tailored to each state's unique needs and contexts, allowing for greater responsiveness to local issues and preventing federal overreach.

While the federal government does have a role in ensuring that elections are free, fair, and accessible to all eligible voters, this should not extend to usurping the states' authority to regulate their elections. Federal involvement should be limited to providing guidelines and support to ensure the integrity and security of elections without dictating specific rules and procedures.

Maintaining the balance of power between the federal government and the states, especially in the realm of elections, is crucial to preserving the fundamental tenets of our Constitutional Republic.
