Please give your answer to each of the following questions and <u>please include your rationale</u> with each answer. Please be concise and clear.

- Please describe the qualifications and experience that make you the best candidate in your political race.
 Answer: I am a small business owner: I manage apartment communities so in essence I run many small business, successfully navigating contract law, budgets, finance, A/P, A/R, payroll etc. I have managed teams of as many as 50employees, successfully.
- Please explain what you believe are the most significant issues in this race, why you are running for this position and what differentiates you from the other candidate(s).
 Answer: I am an America First Candidate. I am looking for a much smaller government run FOR and BY the people. My opponents do not talk of America and Americans First nor do they express a desire a smaller federal government.
- What will be your top 2 or 3 priorities during this upcoming term?
 Answer: We need to drastically cut spending, secure the border, deport illegals, protect the family and end child and human trafficking.
- What is your position about massive immigration over our southern border? Should the federal government renew financing and building the border wall with Mexico?
 Answer: We MUST secure the border and deport all illegals that have come in in the last 5 years. I also propose a 5 year immigration moratorium. This is the only way to protect our elections, infrastructure and culture.

Answer: I am a staunch supporter of the Constitution, and it says that our elections are to be relegated to the states EXCEPT that elections have now been deemed "critical infrastructure". With that, I will meet with constitutional attorneys to perhaps legislate that our elections are held in person, on election day on paper ballots and hand-counted at the precincts. Absentee or mail ballots should only be issued under very special circumstances.
