- Please describe the qualifications and experience that make you the best candidate in your political race.

**Answer: I possess the necessary qualifications in terms of age, residency, and citizenship, rendering me eligible to pursue candidacy for public office. In terms of my attributes, I take pleasure in contributing to the community, whether through philanthropic support for little league teams or providing sustenance to those facing food insecurity.**
- Please explain what you believe are the most significant issues in this race, why you are running for this position and what differentiates you from the other candidate(s).

- What will be your top 2 or 3 priorities during this upcoming term?

**Answer: My foremost priorities include safeguarding our children, reinstating energy independence, and implementing measures to deregulate the federal government.**

4. What is your position about massive immigration over our southern border? Should the federal government renew financing and building the border wall with Mexico?
- Answer: I advocate for the reinstatement of border wall construction and increased funding for the Border Patrol to address the challenges posed by illegal immigration**
5. Should the US Congress legislate that November elections are under Federal control rather than the states regulating their own elections? What is the Federal government's role in setting voting rules and procedures for these elections, if any?
- Answer: I assert that Congress should exclusively regulate the federal election process uniformly. This approach ensures consistency among states, preventing last-minute alterations. Federal laws should pertain solely to the federal election, while state elections remain under state jurisdiction.**
