| 1. Please describe the qualifications and experience that make you the best candidate in your political race. |
| Answer: I am the best candidate in this race because I have a proven record of fighting and winning for conservative values. I was vetted and appointed by President Donald Trump to serve in his Department of Justice and served as Executive General Counsel at America First Policy Institute, taking some of the toughest legal battles for our values. My work has earned the endorsement of Senator Ted Cruz, Governor Greg Abbott, and Lt. Governor Dan Patrick, TX-08 Congressman Morgan Luttrell, Congressman Jim Jordan, and over 150 local, state, and national conservative leaders. I led the fight to protect girls from being forced to compete against biological men, stood up to leftist prosecutors like Manhattan DA Alvin Bragg when they launched political attacks against President Trump, and helped advance strong election integrity laws to protect our ballot. I am battle-tested, unapologetically America First, and ready on day one to take this fight to Congress for Texas' 8th Congressional District. |

2. Please explain what you believe are the most significant issues in this race, why you are running for this position and what differentiates you from the other candidate(s).

Answer: This race is about whether Texas sends another vote to Washington or someone who will help President Trump deliver wins for the MAGA movement. The next two years are critical and President Trump needs fighters. When he needs fighters, he chooses proven leaders—which is exactly why he appointed me to a senior position in his first Administration.

I am running because President Trump needs real allies in Congress who will not only stand with him when the pressure is highest but be able to get things done. I have delivered conservative wins for nearly a decade. Unlike my opponents, I have already been tested. I have taken on the woke Left, defended the President in court, and led the fight to protect girls' sports. This district does not need someone learning on the job. It needs a battle-tested conservative who is ready on day one to help President Trump deliver results.

3. What will your top 2 or 3 priorities be during this upcoming term?

Answer: My top priorities will be supporting President Trump as he advances and codifies the America First agenda during the next two critical years, ending the weaponization of government, and making our communities safer. We must lock in conservative wins so they cannot be undone, hold federal agencies and prosecutors accountable when they abuse their power, and restoring equal justice under the law. I will also focus on public safety by backing law enforcement and stopping the flow of fentanyl so families can live and work without fear.

4. What are your solutions to identifying and cutting fraud and waste in the federal budget?

Answer: I have managed large federal budgets and know where waste hides and how to stop it. At the Department of Justice, I oversaw billions in federal funds and implemented strict oversight to ensure taxpayer dollars were spent as intended and produced measurable results. That experience shaped my approach.

Cutting fraud and waste starts with aggressive oversight, real accountability, and transparency. Programs that fail audits or cannot show results should be reformed or eliminated. Federal agencies must be required to justify spending, not assume it. I also support strengthening inspector general authority, clawing back misspent funds, and holding contractors and bureaucrats accountable when they abuse taxpayer dollars.

5. What are the most important issues that Republicans need to focus on in order to maintain control of the US House in the November 2026 election?

Answer: Republicans need to stay focused on affordability, public safety, and restoring trust in government. Families are struggling with the cost of groceries, gas, housing, and health care, and voters expect Republicans to rein in reckless spending and stop policies that drive prices up.

If Republicans stay focused on lowering costs, protecting communities, and delivering real results instead of distractions, they will earn the trust needed to maintain control of the House in 2026.
