1. Please describe the qualifications and experience that make you the best candidate in your political race.

**Answer:**

I have 50 years of extensive experience and leadership in the conservative movement, nearly 40 of which have been in Texas and Harris County.

I've served as precinct chairman, state chairman of Young Conservatives of Texas and grown the Republican Party through my attraction and training of many volunteers in my campaigns, with several individuals going on to hold county and state offices themselves while others continued as activists in the GOP even after they moved across the state.

Thus, I've fostered the conservative growth and strength of the Party.

I've been in Congress twice, battling the left's agenda both times. I have a record evidencing my sponsorship and co-sponsorship of bills, as well as other actions I've taken on all kinds of conservative issues more extensive than I can provide in a simple succinct response. A few examples:

- Sponsored the Sanctity of Life Act both terms I served and sponsoring the March for Life at the Capitol;
- Authored numerous bills to prevent infringement on the Second Amendment;
- Co-sponsored the Defense of Marriage Act;
- Proposed Constitutional amendment to eliminate birthright citizenship and social benefits to non-citizens;
- Singlehandedly blocked Senate bills on amnesty (S. 744) and sweeping gun control (S. 649);
- Achieved perfect American Conservative Union scores both terms I served;
- Named "Taxpayer Friend" by National Taxpayers Union, "Taxpayers Best Friend" by Citizens for Tax Reform, "Guardian of Small Business" by National Federation of Small Businesses for my fiscally responsible record, and consistently scored A+ by Gun Owners of America.
- Personally confronted EPA Administrator to break a log jam on Exxon licenses for an expansion that provided thousands of new jobs in my district.

I am the only candidate in the race who has served with a proven track record of bills and actions. I've been tested in a crucible, proven, and can absolutely be counted on to not compromise conservative values in any way.

2. Please explain what you believe are the most significant issues in this race, why you are running for this position and what differentiates you from the other candidate(s).

**Answer:**

The fallout from Biden's open borders and illegal immigration, draining our treasury and resources; our corrupt justice system and leftists in our government. Democrats are a threat to our country.

All Republican candidates in this race claim to support conservative positions. The most critical aspect of the race is that of the candidates themselves. That is, who has proven records and shown themselves to be an uncompromising conservative.

I am running to restore America from the damage caused by demonic leftists. Inaction, apathy, compromise, and not following God's will are the causes of our decline.

My record speaks for itself: I have an actual and prolific record of actions taken in the U.S. House.

I consistently stood firm against the Left's agenda, paying the price of lawfare and imprisonment for my bold stances.

On the other hand, one of my opponents led a lawfare impeachment of a national conservative hero and took large donations from the liberal Speaker of the House despised by conservatives, as well as from leftist trial lawyers and developers of the shadily financed Colony Ridge, a haven facilitating illegal immigration and fomenting crime.

3. What will your top 2 or 3 priorities be during this upcoming term?

**Answer:**

- (1) Stopping inclusion of illegal aliens in the census.  
Correcting this error will shift the balance in the House and the electoral college. It will also strip away the advantage of the Democrats' weaponization of illegal immigration.
- (2) Identify and address the dangerous ills America faces due to uncontrolled immigration of the past two decades. Arrest and hold accountable those who are robbing our nation blind.
- (3) Continuing to stand strong for life, our liberties, and Constitutional rights, following not my will, but God's.

4. What are your solutions to identifying and cutting fraud and waste in the federal budget?

**Answer:**

- Eliminate federal agencies and programs that are unconstitutional and cut funding to those agencies' that have failed to meet their mission and responsibilities.
- In 2013 I developed a program using distributive accounting and machine learning that the DOJ and others can use to detect fraudulent payments and waste.
- Require U.S. Government Services Administration to step up acquisition of high tech OneGov IT solutions and mandate agencies' use of them, eliminating duplicative contracts across the government.
- Introduce and pass in the House a companion to the Senate's "DOGE in Spending Act" to codify DOGE's practice of identifying and preventing fraudulent or improper payments, fund modernization of U.S. Department of Treasury's payment oversight system, and require annual certification of each federal disbursement payment's purpose, funding source, and activity type.

5. What are the most important issues that Republicans need to focus on in order to maintain control of the US House in the November 2026 election?

**Answer:**

- The Republicans need to focus on the tremendous success they've had so far, vis-a-vis President Trump and the leading reforms and explosive investments in America. Point out that Democrats' "Obama Care" took money from Medicare and now Democrats want more money to feed insurance companies. Republicans want to give the money to you so you can decide what's best for yourself.
- Promote through ads and staged events the truth of how the Democrats put illegal aliens first and have given illegal allies our Medicare dollars.
