| <b>Answer: As a 6<sup>th</sup> Generation Texan, Christian, and proven entrepreneur in multiple industries: working hard, telling the truth, and delivering on promises has been burned into my DNA.<br/>The MAGA supporting, American First, Conservative person I am today will be the same in DC. I could not have maintain my store's status as one of Texas' largest firearms dealers without unwavering principles, and I refuse to compromise them for establishment, big donors, or anyone else. Integrity is of paramount importance to me and I will not compromise it as a congressman, or for any other position.</b> |

2. Please explain what you believe are the most significant issues in this race, why you are running for this position and what differentiates you from the other candidate(s).

**Answer: The most significant issues in this race for TX-38 are immigration and border security, skyrocketing inflation and national debt, and burdensome property taxes that threaten American homeownership and economic freedom. As a district on the front lines of the border crisis, immigration polls highest because it directly impacts our jobs, schools, hospitals, and public safety. Trump is doing a great job but we're not done yet. We need to complete the border wall, deport all illegal immigrants, and end federal benefits for those who entered unlawfully to put Americans first and protect our communities.**

**I'm running for this position because as a 6th-generation Texan, Christian, licensed minister, husband, father of four, and proven entrepreneur who's built businesses from the ground up, I've seen firsthand how government overreach and failed policies crush families and opportunities. My faith and love for this country compel me to fight for limited government, energy independence, and policies that empower citizens. I've championed property tax reform in Texas to ease the load on hardworking families, and now I want to take that battle to DC to deliver real results for our district, fully supporting President Trump's America First agenda in his final two years.**

**What differentiates me from the other candidates is my proven track record as an outsider business owner I am not a career politician or establishment insider. While others may talk about change, I'll propose the 28th Amendment, the Homestead Security Amendment. Just as the 14th Amendment reinforced federal protections while respecting state sovereignty, this amendment will build on that framework and realize the founding fathers' vision of true fee simple property ownership, free from government seizure through endless taxation. Combined with my commitment to slashing federal waste, reducing the \$38 trillion debt, and strengthening the middle class, my real-world experience navigating regulations and serving my community makes me the strongest advocate for TX-38's conservative values.**

3. What will your top 2 or 3 priorities be during this upcoming term?

**My top three priorities for the upcoming term in Congress for TX-38 will be delivering for American families, securing our future, and restoring fiscal sanity—drawing from my real-world experience as a business owner who's fought government overreach every day.**

**Priority 1: Fully implement and codify the Trump America First agenda, with a special emphasis on immigration and border security. I will fight tirelessly to complete the border wall, deport all illegal immigrants, end federal benefits and entitlements for all non-citizens, and put American workers, jobs, schools, and safety first. This includes codifying key Trump executive orders into law to make them permanent, ensuring no future administration can reverse them. As a 6th-generation Texan on the front lines of this crisis, I'll deliver the secure borders our communities demand.**

**Priority 2: Fight to balance the federal budget, slash the national debt (now over \$38 trillion), and eliminate fraud, waste, and abuse. This especially goes for elected officials. I'll work to cut wasteful programs, hold bureaucrats and politicians accountable, and push for sound fiscal policies that stabilize our economy and reduce the crushing debt burden passed on to our children. My entrepreneurial background of building businesses under heavy regulation gives me the practical insight to identify and eliminate inefficiencies that career politicians ignore.**

**Priority 3: Propose and champion the 28th Amendment—Homestead Security—to ban property taxes on primary homesteads nationwide. Americans should own their homes outright, not rent them from the government through endless property taxes that threaten family stability and generational wealth. This constitutional amendment will secure true fee simple ownership, ease the financial load on Texas families and homeowners everywhere, and fulfill the founding vision of property rights free from government seizure.**

4. What are your solutions to identifying and cutting fraud and waste in the federal budget?

**Answer: I am a staunch supporter of Elon Musk's DOGE efforts which current representatives have shamelessly ignored. Updated technology like AI driven data analytics and systems upgrades will help to identify fraud at the consumer and program levels in real time. This fraud in Medicare, Medicaid, SNAP, assistance grants, contract management and more should not go on for years and rely on a reporter to discover. I will push legislation to impose strict criminal penalties on individuals (including politicians) and entities that misuse the system and rob taxpayers.**

**Government waste is a target rich environment. As a result I will introduce legislation to end wasteful "grants" entirely. Projects truly worthy of taxpayer support should be funded through repayable loans with clearly defined, measurable goals and strict repayment terms. Only in rare cases should performance include forgiveness of the loan. All disbursed funds must face mandatory independent audits, and I'll fight to repurpose elements of the IRS or create dedicated audit teams focused on grant/loan compliance. No increase in budget but rather a redirecting resources from political targeting to protecting the public purse.**

**Continuing with waste, the federal government is bloated with departments and programs lacking constitutional basis, such as the Department of Education, which has failed to improve outcomes while wasting billions. Entire agencies and redundant programs must be eliminated or consolidated to achieve a balanced budget. Drawing from GAO's High-Risk List, which flags dozens of vulnerable areas, I'll target high-susceptibility programs for deep cuts: sunseting ineffective initiatives, enforcing competitive bidding to prevent crony contracts, requiring annual performance metrics with automatic clawbacks for underperformance, and strengthening congressional oversight through dedicated hearings and transparency rules on spending.**

5. What are the most important issues that Republicans need to focus on in order to maintain control of the US House in the November 2026 election?

**Answer: The most important issues Republicans need to focus on to maintain control of the US House in the November 2026 election are delivering tangible results on the America First agenda that voters demanded in 2024. Especially pocketbook concerns like lowering prices and inflation, securing the border and immigration enforcement, slashing government waste and fraud to tackle the massive national debt, and protecting freedoms through smaller, more accountable government. Republicans must unite behind proven principles rather than compromise or gaslight voters.**

**Republicans elected to office need a refresher course on the party's core platform such as smaller government, fiscal responsibility, border security, energy independence, and putting American families first. If they consistently follow these principles, issues like high costs, unchecked spending, and border chaos would become moot. Yet too many appear compromised by establishment pressures, lacking the will, integrity, or intestinal fortitude to stand united against opposition. Voters see this as weakness or outright betrayal, especially when we ask our service members to risk their lives for freedom, but elected officials won't uniformly vote the will of the party or the people.**

**What differentiates me in this race, and what Republicans nationwide should emulate, is unwavering commitment. I am who I am, whether in Texas or DC. I tell the truth without waiver. I'll fight tirelessly for Republican principles**
