Please give your answer to each of the following questions and please include your rationale with each answer. Please be concise and clear.

- Please describe the qualifications and experience that make you the best candidate in your political race.

Answer: I am the only candidate with real courtroom experience, executive leadership inside the Texas Attorney General's Office, and a nationally recognized conservative record under my own name. I've prosecuted criminals as a federal prosecutor, served as First Assistant Attorney General helping manage the largest state law firm in Texas, and represented Texans in Congress fighting for border security, election integrity, and limited government. This office requires readiness on Day One, not on the job training.
- Please explain what you believe are the most significant issues in this race, why you are running for this position and what differentiates you from the other candidate(s).

Answer: Texas faces coordinated threats to the rule of law: an unsecured border fueling trafficking and cartel crime, rogue prosecutors refusing to enforce the law, dark political and ideological networks exploiting our institutions, and widespread fraud and corruption. I'm running because the Attorney General must be a serious law-enforcement leader with the experience to execute, not someone learning the job. What differentiates me is proven execution in the courtroom, inside the AG's office, and against the left's legal and dark money machine.
- What will be your top 3 priorities during your upcoming term?

Answer:

1. Permanently secure the Texas border and dismantle trafficking activity.

I will treat border security as a public-safety and law-enforcement mission aggressively prosecuting human trafficking, cartel operations, and those who facilitate or profit from illegal entry, while using every legal tool available to protect Texans and end exploitation.

2. Stop dark leftist and Islamist networks operating in Texas.

Texas will not be a safe haven for organizations, foreign or domestic, that undermine the rule of law, launder money, engage in fraud, or support extremist activity. As attorney general I will investigate and prosecute these coordinated networks that seek to exploit and threaten our systems, public safety, and sovereignty.

3. Ensure Texans own Texas, not multinational corporations or politically connected interests.

I will defend private property, family farms, small businesses, and energy independence. We must push back against corporate capture of land, infrastructure, housing, food systems, and critical resources. Texas should work for Texans, not global financial interests.

4. What are your solutions to identifying, investigating, and prosecuting public benefit fraud in our state?

Answer: As attorney general I will establish dedicated fraud strike teams that will partner closely with federal and local law enforcement to identify organized and systemic fraud. We will prioritize fraud schemes and the recovery of stolen taxpayer dollars, and then hold both perpetrators and enablers accountable.

5. What strategies will you use to improve efficiencies for investigating and prosecuting crimes, including human trafficking, internet crimes against children, and election fraud?

Answer: We must streamline interagency task forces, modernize analytics, and ensure prosecutors have clear authority and the resources to move cases quickly. That means faster referrals and eliminating jurisdictional bottlenecks so cases result in swift prosecutions and consequences.
