1. Please describe the qualifications and experience that make you the best candidate in your political race.
Answer: 35 years in the private sector employing dozens of people. 40 years as a Texas Republican activist.
2. Please explain what you believe are the most significant issues in this race, why you are running for this position and what differentiates you from the other candidate(s).
Answer: Establishment verses the rank-and-file Texas Republican grassroots activist. I will be the thorn in the side of the establishment that HD138 can support.
3. What will be your top 3 priorities during your upcoming term?
Answer: Reduce regulations across the board, Eliminate property taxes, Privacy protections.
4. What key public state issues do you think need to be addressed by Republicans in 2026-2027, such as AI data centers impact on electricity rates, fraud in state government social programs, DEI, medical rights, infrastructure, etc.?
Answer: Reduced regulations will allow nuclear power plants to be built reducing the cost of energy and allowing the private sector to increase their investments in infrastructure. Means testing of social programs and enforcing current qualification standards for social programs.
5. What is your strategy in working with the Texas Senate to get more of the Texas GOP legislative priorities passed in the next legislative session?
Answer: I already have a working relationship with many of the State Senators and have helped move forward legislation.
