*Please give your answer to each of the following questions and please include your rationale with each answer. Please be concise and clear.*

1. Please describe the qualifications and experience that makes you the best candidate in your political race.

**Answer:** Served two terms as the Precinct 2 Commissioner from 2011-2019. I know how the county works – and where it doesn’t – and I can get in Day One to start untangling the mess the Democratic majority has created.
  
2. Please explain what you believe are the most significant issues in this race, why you are running for this position and what differentiates you from the other candidate(s).

**Answer:** 1. CRIME. We must lower the crime and murder rates. We must start listening to crime victims and their advocates again and we must restore funds law enforcement lost to defunding and see what more is needed to wage a real war on crime. 2. FINANCIAL INTEGRITY. The Democrats have destroyed the county’s reserves – money set aside to respond to hurricanes and other disasters. Financial security must be restored. 3. TRANSPORTATION.
